**Subject:- Delineation/Demarcation of land which do not form part of any water course/source but has recorded as Gair Mumkin Khad, Gair Mumkin Darya, Gair Mumkin Nallah etc. in Revenue Records.**

## **PUBLIC NOTICE**

Whereas, SRO-456 of 25<sup>th</sup> of October 2017 was issued by the Government of J&K in exercise of the powers conferred by Section 4 of the J&K Water Resources (Regulation & Management) Act 2010, by which the Government adopted the State Water Policy and Plan, provides for proper demarcation/delineation of the water sources and course to ensure segregation of Khads which do not form water course/source.

Whereas, pursuant to the Clause 5.2 of SRO-456 of 2017, Government Order No. 18-JK-(Rev) of 2022 dated 04.02.2022 was issued by which the sanction was accorded for the constitution of three-tire committees and the procedure to demarcate/delineate the water source/course which do not for the part of any water course/source but has been recorded as the Gair Mumkin Khad, Gair Mumkin Darya, Gair Mumkin Nallah etc. in the revenue records was accorded. Procedure and terms of reference of the committees as to conduct the Khasra-wise survey of all the land recorded as the Gair Mumkin Khad, Gair Mumkin Darya, Gair Mumkin Nallah etc. and to prepare the maps by means of using modern technology after spot verification on the basis of the status of the land in records of 2010. It also mandated for formulation of comprehensive proposal for rectification of revenue records after the completion of entire exercise.

Whereas, pursuant to the above said Government Order, Deputy Commissioner, Samba issued Order vide No. 33 of 2022 dated 19.02.2022 under Endstt. No. DCS/SQ/2021-22/2449-63, dated 19.02.2022 by which Sub-Divisional Level Committees were constituted to recommend the proposal to

demarcate/delineate the areas which do not form the course/source of any water body but have been recorded as Gair Mumkin Khad, Gair Mumkin Darya, Gair Mumkin Nallah etc. in the revenue records after conducting the Khasra-wise survey of all such land by preparing the maps besides taking the remedial measures and action for the illegal encroachments/constructions obstructing the natural flow of water in the channel/course recorded as Gair Mumkin Khad, Gair Mumkin Darya, Gair Mumkin Nallah etc. in the revenue records.

Whereas, a meeting of all the SDMs/ACR was held on 26.04.2022 under the chairmanship of Deputy Commissioner, Samba in which it has decided to conduct the mapping through DGPS system which is being adopted by JDA for the mapping of the land. In the meeting of the District Level Committee which was held on the matter on 05.05.2022, the issue for engaging an external agency for creation of Delineation/demarcation Maps through DGPS system was deliberated and it was decided to engage the external agency already engaged by the JDA for similar nature of work on the similar terms and conditions keeping in view the strict timeline of three months to complete the survey. It was also decided to conduct the survey of the revenue villages falling within the limits of Sub Divisional Magistrate, Ghagwal in the first phase.

Whereas, the Sub-Divisional Level Committee in respect of Sub-Division Ghagwal constituted for the purpose deliberated and report of Flood Control Department on the issue in its meeting on 04.04.2022, 20.05.2022, 10.06.2022 and 04-07-2022 and chalked out the strategy for delineation/demarcation of such area.

Whereas, the mapping and survey of the areas/revenue villages falling under the limits of the Sub Divisional Magistrate Ghagwal through DGPS/GIS have been completed and the Sub-Divisional Level Committee has finalized the report with its recommendations on the basis of field visits along with residents of village Rajli.

Whereas, the Sub-Divisional Level Committee proposes to delineate/demarcate the areas which do not form the course/source of any water body but have been recorded as Gair Mumkin Khad, Gair Mumkin Choi, Gair Mumkin Rohad etc. in the revenue records and recommends to record the such areas (village-wise) as the

Gair Mumkin in the revenue records as these are not the part of water course/source as Annexure- A to this notice.

Whereas, the recommendation of the committee are put in the public domain to invite/seek objections of the public/interested parties to the proposal/recommendations of the committee by publishing the same in the print media. The proposal/recommendations can be accessed online on the link (samba.nic.in). If anybody is having any objection to the proposal/recommendations, he/she is requested to furnish the objection to the proposal in writing in the office of the Sub-Divisional Magistrate & Tehsildar Ghagwal/Rajpura during the office hours within 15 days from the publications of this public notice.
