Notification No. 01 of 2022 Dated : 26-11-2022

Whereas, it appears to the Government of U.T. of J&K that a total of 103 Kanal - 04 Marlas of land is required in village Londi Tehsil Hiranagar District Kathua for public purpose, namely for construction of 135ft composite bundh on the Indo - Pak Border. Regarding Rehabilitation & Resettlement Policy and Social Impact Assessment Study, it has been reported by the field staff that no family is being displaced from the said land.

Whereas, the land is urgently required for the project falling within the purview of Section 40(2) and the same has approval of the Revenue Department, Civil Secretariat, Jammu / Srinagar vide Order No. Order No. 136-JK- (Rev) of 2021 dated 16-11-2021 issued under endorsement no. Rev-LAJ/113/2021(74473) dated 16-11-2021 has exempted undertaking of Social Impact Assessment Study under section 9 read with section 40 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, for the subject acquisition.

Therefore, it is notified that for the above said project in the village Londi Tehsil Hiranagar District Kathua, a piece of land measuring 103 Kanal - 04 Marla, of standard measurement whose detailed description is annexed as Annexure -A, is under acquisition :-
