
Whereas, the Council staff after scrutiny of response cited above informed that the communication (List/Record) received from" Monad University, Hapur "as cited above presumably not originating from the bonafide source;

Whereas, the above inputs were taken on record and as an abundant precaution an exercise was initiated in a confidential manner vide this office communication/mail no: JKPC-Estt/211-218, Dated: 03.07.2023 to unfold the facts surrounding the concerns highlighted above;

Whereas, the Registrar & Director Administration, Monad University, Hapur, U.P vide their communication /mail Dated: 10.07.2023 has vehemently disowned the issuance of record submitted vide: MU/VER/2022-23/134, Dated: 22.03.2023 from their side in respect of candidates quoted under reference communication;

Whereas, on the basis of information accessed during investigation, it has now become amply clear that the above mentioned applicants have indulged in manipulation & misrepresentation in order to seek a lateral entry into the register of Pharmacists maintained by the J&K Pharmacy Council in the Union Territory of Jammu & Kashmir;

In light of contents of foregoing paras, the applications of all such applicants whose credentials have been disputed by the concerned competent authority by the university and also those candidates who had applied through online portal on the basis of claiming to have acquired the requisite eligibility from the above university namely " Monad University, Hapur" are hereby rejected ab-initio.
