Madam,

A meeting of Screening Committee was held in the Office Chamber of Deputy Controller, Drugs & Food Control Organization, Jammu on 22.11.2023 to discuss the subject case . The following Officers / Officials were present in the meeting.

1. Sh. Mohd Iqbal Pala, Deputy Drugs Controller, Jammu
2. Sh. Arvind Sharma, Assistant Drugs Controller, Jammu.
3. Smt Archana Mujoo, ,ADC (HQ),Jammu.
4. Sh Pankaj Malhotra Assistant Drugs Controller (ILC) Jammu
5. Smt Bhawna Bhat, Drugs Control Officer (HQ) Jammu

During the meeting, the subject case was discussed thoroughly & observations along with recommendations are as follows:

A drug sample of **DUMONT-L B.No:-DML-1005, MfgDt:-01/2022, Exp.Dt:-12/2023, Manufactured by:- ULTRA CHIRON PHARMACEUTICALS (P) Ltd 575, PH-IX, IND AREA MOHALI-160062 ; Mkted By:- D. H LIFESCIENCES 1-2,11/B DOMALGUDA HYDERABAD-500029** was lifted by Drugs Inspector (RAMBAN) for the purpose of test and analysis from M/S Nazir Medical Hall, Main market Gool Tehsil Gool District Ramban.

The said drug sample has been declared to be Misbranded by the Govt. Analyst, CFDL, Jammu Vide test report No: CFDL/J/2022-23/2051 dated 16.03.2023

The Concerned Drugs Inspector Vide letter No. DI/RBN/315-18 dated 08.08.2023 took the matter with the incharge of M/S Nazir Medical Hall, Main market Gool Tehsil Gool District Ramban as provided under section 18A/B of the Act.

Pursuant to the letter from Concerned Drugs Inspector, the incharge of M/S Nazir Medical Hall, Main Market Gool Tehsil Gool District Ramban vide his letter No:-RDWH/R/2022/233-235 dated 27/10/2022 has disclosed that the drug in question has supplied to him by M/S RS Pharmaceuticals ,Jagan Market Mohalla Paharian ,Jammu vide letter no Nil dated 04/11/2023.

Further ,M/s RS Pharmaceuticals,Jagan Market Mohalla Paharian ,Jammu was directed to submit the source of procurement & distribution who in turn in his reply dated: -04.11.2023 has disclosed that drug in question has been supplied by M/S D.H Life Sciences SCF 31,Ist Floor C-7 ,Phase-1 Mohali vide invoice nos:DH/22-23/018,020,025,024,029dated:02.09.2022,15.10.2022,29.12.2022,26.11.2022,24.02.2023 respectively.

The Concerned Drugs Inspector ,Distt. Ramban then further took the matter to M/s D.H Life Sciences SCF 31,Ist Floor C-7 ,Phase-1 Mohali vide his letter no-DCO/RBN/457-60 dt- 29.11.2023 was directed to submit the source of procurement & distribution who in turn in his reply dated: -30.10.2023 vide invoices No.DH/21-22/29 dated 08.03.2022 and DH/22-23/11,16,18,20,24,25 dated 26.04.2022, 14.06.2022, 20.08.2022, 02.09.2022, 15.10.2022, 26.11.2022 and 29.12.2022 respectively has disclosed that drug in question has been supplied by M/S Ultra Chiron Pharmaceuticals P Ltd 575,PH-IX,IND.Area Mohali-160062 .

The manufacturer of drug in question i.e M/S Ultra Chiron Pharmaceuticals P Ltd 575,PH-IX,IND.Area Mohali-160062 has disclosed the drug in question has been Manufactured by their firm in response to the letter No. DCO/RBN/461-64 dated 20.08.2023 & have submitted that that they had taken Corrective and preventive measures to prevent such type of observation in future enclosed here with sample of fresh labels of the said drug.

Further it is submitted that as per the guidelines of Central Drugs Standard Control Organization (CDSCO) Ministry of Health & Family, Govt of India, the defect of the Drug in question fall under category "C". It is therefore recommended Administrative Action (AA) may be taken against the Manufacturer & also investigation report shall be taken before the Screening Committee (SC) of the department.

Accordingly, the matter was discussed in the meeting of Screening Committee and from the perusal of the Case & recommendations of Assistant Drugs Controller, Ramban vide his letter No DADC/UDH/2023-24/354-57 dated 29.11.2023 & Drugs Control Officer,Ramban vide his letter no DCO/RBN/450-53 dated 29.11.2023 respectively ,therefore the members of Screening Committee are of the opinion that since subject Drug has been declared Not of Standard Quality for the reason that the sample is Misbranded which falls under minor category defect as per the guidelines of CDSCO. Therefore, Controller, Drugs & Food Control Organization, J&K, Jammu may be requested to take up the matter with the concerned quarters i.e. State Licensing Authority to initiate Administrative Action against the Manufacturer.
