The Inquiry Officer shall conduct a detailed enquiry into the matter and shall submit his report/findings with specific recommendations to the Administrative Department within a period of 15 days from the date of issuance of this order.

Any modification in posting shall not debar the Inquiry Officer and the Presenting Officer in performing their duties as assigned vide this order.
