- i) To review the functioning of JKBOCWWB and also examine best practices adopted by the other states/UT's.
- ii) To submit a SWOT based report on the Boards performance in implementing existing welfare Schemes.
- iii) To devise a mechanism for 100% coverage of insurance for all construction workers and saturation of PMJJBY, PMSBY, PMSYMY & SEHATSCHEME.
- iv) To submit the comprehensive proposal for imparting skills to the construction workers and their wards as per market requirement.

- v) To submit a report for 100% coverage of construction workers falling under the ambit of PM Vishwakarma Scheme.
- vi) To submit a report on Smart Card to be provided to the Construction workers registered with Board.
- vii) To advise on implementation of more welfare based schemes for orphans, widows of construction workers.
- viii) To submit a comprehensive report on, how to carry out extensive Information, Education & Communication (IEC) activities for dissemination of welfare Schemes run by the JKBOCWWB to the targeted groups.
- ix) To submit a comprehensive proposal for Scholarships to be provided to the meritorious wards of the construction workers for pursuing professional courses and coaching facilities for competitive exams.
- x) To devise a mechanism for augmentation of Labour cesscollection.
- Xi) To submit a proposal for better returns of the funds available with the JKBOCWWB.
- xii) To submit a report for establishment of 02 state of the art model residential schools for the wards of the construction workers.

Any other suggestion/recommendation by the Committee.

The aforementioned committee shall submit its reports by or before 5.30 pm of 10th of May, 2024 positively.
