Subject:- Issuance of transfer and postings of officials of E&S Cadre.

Madam,

Please refer your letter No. DES-ESTTOADM/34/2024/478-83 dated 19-04-2024 & another letter No.DES/PF/JSA/KDC/309(Adm)/515-18 dated 22-04-2024.

I would like to inform you that before addressing these two communications to us, it would have been appropriate if the facts had been verified by your subordinate staff.

Mr. Bashir Ahmad Bhat, Junior Assistant having CPIS No. (TRLAGR00020128) has been posted in RDD, District Pulwama since 23-12-1997 and it is only for a brief period (27-06-2006 to 06-08-2007) that he has remained with DSEO, Pulwama.

Mr. Farooq Ahmad Mir, Junior Assistant posted in BDO office Tral & Mr. Masood Ahmad Baba, Junior Assistant posted in BDO office Pampore, are in RDD from last 5 and 6 years respectively and were shifted by ACD, Pulwama as they were posted in Blocks of their residence and were holding sensitive sections and there were reports and also apprehensions of them misusing their official positions in the ensuing Parliamentary Elections of 2024.

Further, Mr. Satish Chander Kattal, JSA is deputed to Administrative Department in pursuance to Government order No. 82-RD&PR of PR of 2017 dated 22-02-2017, issued by Administrative Department of RD&PR.

Apart from the above clarification I would like to bring the facts regarding the shifting of the planning staff to your notice. I am sorry to say that you have been sitting on the files and telling us how come these officials are overstaying in your Department.

In order to make it more clear and transparent, I want to refresh your memory. Last year we were expecting that officials of Planning Department with a mature stay who are on deputation with RDDK will be transferred but nothing like that happened.

On 17-4 2023 we requested vide No. DRDL/Estt/23/Gnl/2015/2174-76 dated 17.04.2023, for shifting of 104 officials who had mature stay in our Department. It was processed by our Administrative Department through e-office

and one

CC No. 7178102 on same day and was sent to your Department on 29-04-2023 and to you on 01-05-2023.

You could find time to process the file after a gap of one month and 20 days and on 20-06-2023 you write at note#14,

"Director Rural Development Department has proposed transfer of 104 officials (SO/ JSA / Jr Asst) posted in various blocks of Kashmir Division. Some of the officials have already been transferred in the month of April, 2023 as per the transfer policy notified by the GAD. It is not possible to transfer all 104 officials in one go that too in the mid of session.

As regards, authorizing Rural Development Department to make internal changes, it will create administrative issues, since the Directorate of Economics and Statistics (controlling authority) will not be in a position to have track of these officials/ records. However, if the Rural Development Department is in need of few transfers which are urgently required within the blocks itself, the same can be considered by the department if it meets the approval of Administrative Department (PD&MD). "

After Discussing the file with your Administrative Secretary it took one month and 02 days for you to put up another note on 22-07-2023 with the following content:-

As discussed, out of 104 officials proposed for transfer by Rural Development Department, the following officials have either been already transferred / retired or having pre-mature stay as shown below:-

It is not possible to transfer all remaining officials in one go that too in the mid of the financial year. However, if the Rural Development Department is in need of few transfers which are urgently required within the blocks itself, the same can be considered by the department if it meets the approval of Administrative Department (PD&MD).

As regards, authorizing Rural Development Department to make internal changes, it will create administrative issues, since it will be difficult for the Directorate of Economics and Statistics (controlling authority) to have track of these officials/ records and handle the HRM related issues".

It was never the middle of the financial year. It was only because of the time the file remained un-attended in your office that it reached mid of the financial year.

The file was resubmitted again after verifying the status of the 75 officials of your Department on 12-09-2023 and is still lying with your office.

Another file under CC. No. 7410621 was initiated through e-office on 19-02-2024, with the same request and it is pending disposal with you since 22-02-2024 although the official transfer window to shift these officials was unt Ont available with you.

I have made dozens of calls and also messaged you to shift the officials having mature stay, but no response was received from your end.

It is not about these 04 employees, I would like to remind you that many of the officials of your Department are with us for more than 10 years and I don't hesitate to say that all officials with mature stay cannot be in RDD without the connivance of your officials.

As a reference I would like to share the list which we have shared with you last time detailing the stay position of these employees.
