However, the Director of Planning in the School Education Department shall monitor the monthly progress in this regard from the Administrative level.

The Terms of reference (ToR) of the Committee shall be as follows:-

1. Review and Analysis: Conduct a comprehensive review and analysis of the NEP 2020 recommendations, aligning with its objectives.

2. Action Plan: Develop a detailed action plan for the implementation of NEP 2020, including timelines and milestones

3. Stakeholder Engagement: Facilitate engagement with relevant stakeholders, including government agencies, educational institutions, civil society organizations, and experts in the field of education.

4. Monitoring and Evaluation: Establish mechanisms for monitoring progress and evaluating the effectiveness of the implementation efforts, ensuring alignment with the NEP indicators

5. Capacity Building: Identify capacity-building needs and initiatives required to support the implementation of NEP 2020.

6. Policy Advocacy: Advocate for policy changes and reforms necessary to

align existing education policies with the goals of NEP 2020.

7. Documentation and Reporting: Maintain records of all activities, decisions, and outcomes of the NEP Cell and prepare periodic progress reports for submission to the relevant authorities.

8. Coordination: Coordinate with other government departments and agencies involved in education-related initiatives to ensure synergy and avoid duplication of efforts, as per the coordination mechanisms outlined in NEP 2020.
