# Terms of Reference:

- i. To record details of events under which the land has been transferred by JKI Limited to JKPCC and the circumstances which led to retrieval of land by JKI from JKPCC.
- ii. To recommend an amicable solution viz-a-viz transfer of possession of 234 kanals of land at Brick and Tiles Factory, Pampore from JKPCC to JKI Limited and measures required to be taken to finalize and settle the financial obligations of both the Corporations towards each other.

iii. To recommend any other measure required to set the record straight in relation to assets and liabilities of both the Corporations.

The Committee shall be serviced by the Industries and Commerce Department and shall submit report/recommendations within a period of one month.
