 The Government Counsels shall accompany copy of objections/Reply/ Statement of facts, etc along with the receipt of filing of the reply/statement of facts from the concerned department (dealing officer/ official).

3. The covering letter/bill shall compulsorily indicate case No, complete title of the case, document filed, date of filing, department and entitled

amount etc. as per rules.

4. The designated cell for incidental charges in the Department of Law Justice and Parliamentary Affairs shall make an endeavor to clear the bills complete in all respects with in a period of five working days as per the standing orders occupying the field.
