Terms of Reference:

To examine the Certificate(s) furnished by implementing agency/Original equipment Manufacturer/service provider with regard to Electronic Enforcement devices installed for issuance of a *challan*, are in conformity with the requirements specified in Section 167-A of Central Motor Vehicles (Seventeenth Amendment) Rules, 2021, notified vide GSR 575(E)

- issued by the Ministry of Road Transport and Ministry of Highways, Government of India.
- ii. To give recommendations/suggestions to the Designated Authority in a time bound manner so that seamless issuance/renewal of certificates of Electronic Enforcement devices is carried out.
