In accordance with Govt. of India Gazette Notification dated 29.06.2021, the Central Government has levied fee for use of completed four lane **Quazigund to Banihal Section** from design Km 189.350 to Km 205.618 of National Highway number 1A (New NH-44) in the state of Jammu & Kashmir. Accordingly, Collection of User Fee at revised rates to be applicable from 03-06-2024 (00:00 Hours) at Toll Plaza at Km. 193.760 (design chainage) near village Lamber in Ramban District of NH-1A and at Km 204.503 (design chainage) near village Ujroo in Anantnag District of NH-1A at the following rates for the year 2024-25 as under:

Fastag monthly passes shall be issued from the Toll Plaza (copy of vehicle registration certificate and proof of residence required)
- Mechanical vehicles loaded in excess of permissible limit shall be charged as per the guidelines issued by Ministry of Road Transport & Highways (Govt. of India).
