Subject: Apportionment of manpower between the Union Territory of Jammu & Kashmir and the Union Territory of Ladakh.

Government Order No.1177-JK(GAD) of 2024 Dated:07-06-2024

WHEREAS, vide Government Order No. 1212-JK(GAD) of 2021 dated 15.11.2021 read with Government Order No. 505-JK(GAD) of 2022 dated 05.05.2022, Government Order No. 1254-JK(GAD) of 2022 dated 17.10.2022, Government Order No. 468-JK(GAD) of 2023 dated 17.04.2023 and Government Order No. 24-JK(GAD) of 2024 dated 03.01.2024, 14,795 employees serving on substantive basis in the erstwhile State of J&K, have been apportioned to the Union Territory of Ladakh on the basis of options exercised by them and in terms of Section 89 of the Jammu and Kashmir Reorganisation Act, 2019;

AND WHEREAS, the Government Order No. 1212-JK(GAD) of 2021 dated 15.11.2021, further provided that the apportionment of remaining employees referred by the Union Territory of Ladakh shall be considered upon recommendations of Union Territory of Ladakh after due verification/certification of their service records/ credentials by the latter;

AND WHEREAS, the General Administration Department, Union Territory of Ladakh vide communication No. A/95/2021-O/o Un Secy-GAD dated 22.03.2024, after due verification of their initial appointment/ selection orders at its level also forwarded the duly verified service records of 100 employees and recommended of their apportionment to Union Territory of Ladakh;

AND WHEREAS, vide Order No. 149-LA(GAD) of 2024 dated 26.03.2024, the General Administration Department, Union Territory of Ladakh deputed officer/ officials along with relevant records for joint verification of records of the above employees recommended for apportionment to the Union Territory of Ladakh;

AND WHEREAS, during joint-verification it was observed that ten (10) employees out of the aforesaid 100 employees cannot be considered for apportionment to the Union Territory of Ladakh, on account of reasons indicated against each:

NOW THEREFORE, on the basis of definitive recommendations of Administration of Union Territory of Ladakh and in exercise of the powers under Section 89 of the Jammu and Kashmir Reorganisation Act, 2019, the Lieutenant Governor of the Jammu and Kashmir, is pleased to apportion ninety (90) employees figuring in **Annexure** to this Order, to the Union Territory of Ladakh, subject to the following conditions:

- i. Further verification of genuineness of initial appointment orders/ service records of these employees shall be carried out by General Administration Department, Union Territory of Ladakh and in the event of discovery of any deficiency, the apportionment of the employee(s) to that extent shall be deemed to have been withdrawn ab-initio.
- ii. Any variation in the details/ credentials of the above employees shall be rectified only after considering original/ verified service records by the concerned Controlling Authorities, with the approval of the competent authority in the Union Territory of Ladakh.
- iii. The employees apportioned to Union Territory of Ladakh and are presently continuing their service in the Union Territory of Jammu & Kashmir shall be relieved by the concerned Administrative Departments immediately.
