Sanction is hereby accorded to the constitution of an Empowered Committee for implementing the Scheme: "Strengthening Consumer Commission for the period 2021-22 to 2025-26" in the Union territory of Ladakh. The Committee shall be comprised of the following Members / Officers.

1.	Advisor to Hon'ble Lt. Governor, UT of Ladakh.	Chairman
2.	Administrative Secretary, Finance Department, UT of Ladakh.	Member
3.	Administrative Secretary, Industries & Commerce Department, UT of Ladakh.	Member
4.	Administrative Secretary, Food, Civil Supplies & Consumer Affairs Department, UT of Ladakh.	Member
5.	Representative of Department of Consumer Affairs, Government of India.	Member
6.	President of State Consumer Disputes Redressal Commission, J&K	Member

**The Terms of Reference of the Committee shall be to:**

- i. approve proposals seeking financial assistance from the Central Government.;
- ii. ensure that proposals for consideration of the Empowered Committee should have been submitted in consultation with their respective UT Commissions.;

- iii.* ensure that the Consumer Commission for which assistance is being sought should be fully functional *w.r.t.* creation of posts of President and Members.;
- iv.* approve proposals for utilization of the funds provided by the Central Government for construction of buildings and purchase of non-building assets.;
- v.* make further allocation of funds for the construction / strengthening of infrastructure of individual Consumer Commission, based on local need analysis.;
- vi.* decide as to how to release the funds and to which Commission it should be released according to the needs and requirements arising from time to time.;
- vii.* recommend reallocation of unspent balanced for other Consumer Commission within the UT depending on requirement & eligibility.,
- viii.* monitor and review at regular intervals the progress of construction and utilization of the funds released by the Central Government.
