Terms of Reference (ToR) for the UT Level Coordination Committee:

1. Regularly undertake review of progress under the Scheme under all components.
2. Facilitate necessary coordination between Departments for implementation of the scheme.
3. Prepare an Action Plan for saturation of all Government Buildings with Rooftop Solar.
4. Review the status of Rooftop Solar installation in Government Buildings and to monitor and supervise implementation of the Action Plan for saturation of all Government Buildings in a time bound manner.
5. Facilitate convergence of efforts between Departments at the field level to maximize impact of awareness, capacity building and rooftop solar installation, particularly in existing beneficiaries of other government schemes.
6. Coordinate with Ministry of New and Renewable Energy, Government of India regarding scheme implementation and to suggest measures to improve scheme implementation in the UT.

The State Implementing Agency for PM Surya Ghar: *Muft Bijli Yojana* shall provide the necessary secretarial assistance to the UTLCC.

4. To facilitate convergence of efforts between Departments at the field level to maximize impact of awareness, capacity building and rooftop solar installation, particularly in existing beneficiaries of other government schemes.
5. To coordinate with National Program Implementation Agency (NPIA) regarding scheme implementation and to suggest measures to improve scheme implementation in the district.
6. To facilitate and review the implementation of Model Solar Village Component of the scheme.

The District Unit of State Implementing Agency for PM Surya Ghar: *Muft Bijli Yojana* shall provide the necessary secretarial assistance to the DLC.

The Committee may convene at least once every three months.
