- Coordinate and follow up activities between FRRO & FROs regarding tracing and deporting of foreign nationals staying illegally in the UT of J&K.
- 3. Monitor the progress achieved on the issues on the subject, in consideration, from to time to time and report to Home Department on regular basis on these issues after compiling from FROs.
- 4. Disseminate, communicate and circulate information between FRRO & FROs pertaining to the various cases sub-judice on the subject in different courts and regularly monitor, update and inform status of these cases to the concerned quarters.
- 5. Nodal Officer shall also monitor capturing the biographic and biometric details of illegal migrants and report the progress achieved to the Home department after compiling from FROs and maintain up to date record digitally on regular basis, of those illegally staying in the UT of J&K.
