**The Terms of Reference of the Committee shall be:**

(i) Overall implementation and monitoring of the Scheme, including compliance with the Scheme guidelines at the UT Level;

- (ii) Reviewing UT - wide progress of Scheme including the work plans and budget and taking corrective action;
- (iii) Conducting periodic review of the progress of the Scheme at UT Level;
- (iv) Reviewing progress and achievement of Key Performance Indicators (KPIs) to analyse the outcome of the Scheme at any point of time;
- (v) Seeking periodic reports from the District Skill Committees (DSCs);
- (vi) Monitoring and reviewing the progress through DSCs and reporting the progress to State Skill Development & Entrepreneurship Committee (SSDEC) on apprenticeship engagement and to MSDE;
- (vii) Reviewing the UT-level awareness and mobilization efforts under the Scheme;
- (viii) Coordinate/support scheme impact evaluation/assessment studies at the ground level;
- (ix) Compiling recommendations from UT-level stakeholders for putting forward to SMRC and / or taking necessary actions on them as may be deemed fit; and
- (x) Any other matter as matter as may be relevant for the effective implementation of the Scheme.
