 - ix. The official so deployed shall furnish an undertaking duly attested by the 1st Class Magistrate stating therein that he/she has no right to claim for permanent absorption in the department/Corporation and will not approach any Hon'ble Court of Law for the said purpose.
 - x. The Pay level and designation shall not be taken as authentic and shall be subject to further verification.
