GHSS Bandipora -Reinstatement thereof.

WHEREAS, Mr. Nayeem Ahmad Parray, Sr. Lecturer Physics, GHSS Bandipora
was placed under suspension vide Government Order No. 332-JK(Edu) of 2023 dated
13.10.2023 and was attached in the Directorate of School Education, Kashmir;

WHEREAS, the Director, School Education, Kashmir was directed to conduct an
inquiry into the matter and submit findings along with recommendations to this
department;

WHEREAS, Director, School Education, Kashmir vide his letter No.
DSEK/IMW/7316541/AG-Sus/201-202 dated 20.01.2024 has reported that the matter
was got inquired through Chief Education Officer, Bandipora by the Director, School
Education Kashmir vide Order No. 287-DSEK of 2023 dated 28.10.2023;

WHEREAS, the Inquiry Officer vide his office letter No. CEO/Bpr/Misc/2023/2921
dated 14.11.2023 has reported and the said lecturer was granted absolute bail by the
Hon'ble Court of Session Judge, Bandipora vide order dated: 17.01.2023 and also the
offenses U/S 9/10 POSCO Act were dropped against the accused and matter is
presently sub-judice in the competent court of law;

WHEREAS, the Director School Education, Kashmir has recommended the
reinstatement of the said lecturer, so that his services are utilized in some other boy's
specific institution;

WHEREAS, after examining the inquiry report, the case was placed before the
Suspension Review Committee, which met on 31.05.2024 under the chairmanship of
the then Administrative Secretary, School Education Department, and the Committee
decided in the instant case as under:-

1. The suspension review committee on the basis of report of Director School
Education, Kashmir has conveyed that the allegations of ripping off the
hijab and physical harassment of the complainant in the classroom does not
seem to be true and the said lecturer was granted absolute bail by the
Hon'ble Court of Session Judge, Bandipora vide order dated: 17.01.2023
and also the offenses U/S 9/10 POSCO Act were dropped against the
accused and the case is presently sub-judice in the competent court of law.
The Director School Education, Kashmir has recommended the
reinstatement of the lecturer, so that his services are utilized in some other
boy's specific institution.

2. The committee recommended that the officer be reinstated with immediate effect, and his period of suspension be treated as on duty subject to verification/production of attendance certificate.
3. The reinstatement order shall remain subject to the outcome of court case pending before the Hon'ble Session Judge, Bandipora.

WHEREAS, in the meanwhile, the department vide letter dated 24.06.2024 requested Director, School Education, Kashmir to furnish the attendance report of the Lecturer in question;

WHEREAS, Director, School Education, Kashmir vide letter No. DSEK/Estt-1/7316541/836 dated 05-07-2024 has intimated that Mr. Nayeem Ahmad Parray, Senior Lecturer, Physics, GHSS Bandipora pursuant to his suspension joined Directorate of School Education, Kashmir on 14-10-2023 and remained attending in Directorate of School Education Kashmir w.e.f 14-10-2023 to till date;

NOW, THEREFORE, sanction is hereby accorded to the reinstatement of Mr. Nayeem Ahmad Parray, Senior Lecturer, Physics, GHSS Bandipora with immediate effect and the period of suspension is treated as on duty, under rules. Further, the reinstatement of the lecturer shall remain subject to the outcome of court case pending before the Hon'ble Session Judge, Bandipora.
