Jammu, the 13th August, 2024

- S.O. **393**.-In exercise of the powers conferred by section 3 of the Essential Commodities Act, 1955 (10 of 1955) read with clause 9 of the Targeted Public Distribution (Control) Order, 2015 issued by the Government of India in the Ministry of Consumer Affairs, Food and Public Distribution published as G.S.R 213(E) dated 20th of March, 2015, the Government of Jammu and Kashmir hereby make the following amendments in the Jammu and Kashmir Targeted Public Distribution (Control) Order, 2023; namely:-
 - 1. In sub-clause (1) of clause 3, the following proviso shall be added; namely:-
 - "Provided that in respect of Kashmiri/Jammu Migrants, such ration cards shall be issued by or on the recommendations of the Relief & Rehabilitation Commissioner (M)".
 - 2. In sub-clause (1) of clause 5, the following proviso shall be added; namely:-
 - "Provided that in respect of Kashmiri/Jammu Migrants, applications for such purpose(s) shall be submitted to the Relief & Rehabilitation Commissioner (M)".
 - 3. In clause 6, the following proviso shall be added; namely:-

"Provided that in respect of Kashmiri/Jammu Migrants, such ration cards shall be issued by the Relief & Rehabilitation Commissioner (M) or on the recommendations of the Relief & Rehabilitation Commissioner (M)".
