Government Order No.1496-JK(GAD) of 2024 Dated:13.08.2024

It is hereby ordered that the appointment of Hon'ble Justice (Retired), Shri Maharaj Krishan Hanjura, Chairman of the "Committee for Fixation of Fee Structure of Professional Colleges in the Union territory of Jammu and Kashmir", constituted vide Government Order No. 1120-JK(GAD) of 2024 dated 31.05.2024, shall be governed by the following terms and conditions:-

1	Pay	As admissible to a sitting Judge of Hon'ble High Court, minus pension and commuted portion of pension, if any.
2	TA/DA/Medical Allowance/ other conditions of service	As admissible to a Judge of the Hon'ble High Court.
3	Conveyance	Staff car to be provided by the Motor Garages Department with 200 liters of petrol per month or actual consumption (whichever is less).
4	Accommodation	Rent free accommodation, or in lieu thereof, House Rent Allowance as per entitlement of a sitting Judge of the Hon'ble High Court.
5	Telephone	Telephone at office and residence with a limit of 1000 calls per month for the latter.
6	Sumptuary Allowance	As permissible to a sitting Judge of the Hon'ble High Court.
