Subject: - **Visit of VVIPs to District Poonch on 21-09-2024 & 22-09-2024 – Declaration of No Flying Zone U/s 163 of BNSS thereof.**

ORDER

Whereas, in view of the visit of the VVIPs which is scheduled on 21-09-2024 & 22-09-2024 various security measures are being undertaken by the administration; and

Whereas, as a measure to strengthen security, there shall be restriction on arrival photography/videography in any form by usage of drone, balloons etc. and hence there is sufficient ground for proceeding, for which immediate prevention is required.

Now, therefore, I, Tahir Mustafa Malik, JKAS Addl. District Magistrate, Poonch in exercise of the power conferred upon me under section 163 of BNSS 2023, with a view to ensure strengthened security during the visit of VVIPs on 21-09-2024 and 22-09-2024, declare the whole of District Poonch as '**No-Flying Zone**' and do hereby prohibit the flying of any kind of aviation devices, including UAV/drones/balloons etc. in District Poonch on from 10:00 AM of 20-09-2024 to 03:00 PM of 23-09-2024.


Any violation of this order is punishable by legal action under section 223 BNS and other relevant provisions of law.

The order shall come into effect on 20-09-2024 at 10:00 AM and remain in force till 03:00 PM on 23-09-2024.

The emergent nature of case and circumstances do not permit serving of notice to the concerned in due time and hence this order is passed ex-parte under section 163 (2) of BNSS, 2023)

The Senior Superintendent of Police, Poonch shall ensure the implementation of this order in letter and spirit.
