The present Mission Director, National Health Mission, J&K Nazim Zai Khan, IAS holding additional charge of Mission Director, Ayushman Mission, J&K Digital has illegally Bharat established and appointed 10 officials for the Project Management Unit (PMU) of ABDM Project, J&K. No advertisement for General Public has been issued in any print or electronic media. Besides, these opening have not even been put up on the official clandestine ABDM website. The appointment of the 10 officials whose names are given below belong to highly affluent families mainly connected to the National Conference, J&K. A web-link was created through an outsourcing agency by the NICSI New Delhi who forwarded the link to these specific 10 persons on 29th August, 2024. No regular selection criteria and process was adopted through any competitive means to select these candidates. The helow named candidates joined in the office of Mission Director NHM/ MD ABDM, J&K on 6th of September, 2024 in gross violation of the Model Code of Conduct and throwing all the rules and regulations governing such engagements to the winds. The below mentioned candidates have been selected.

- 1. Abdul Gani, appointed as Project Manager without requisite qualification.
- 2. Dr Afeera, has been appointed as MIS expert in ABDM, J&K.
- Mirgya Bakshi who was earlier working in NIPI India deployed in J&K was asked to resign from NIPI and joined as Consultant IT.
- 4. Dr. Sonalika Jamwal who was earlier working in NIPI India deployed in J&K was asked to resign from NIPI and joined as Consultant HMIS expert.
- 5. Mr. Vikram who operating was an outsourcing namely agency Tiranga Manpower and Solution has been appointed Analyst in ABDM Business without as requisite qualification.
- 6. Duha Majeed Salroo has been appointed as Capacity Building Officer without requisite qualification.
- 7. Dhanush Sharma has been appointed as Project Coordinator Jammu.
- 8. Nasir Wani (B.Com) has been appointed as IEC Manager in ABDM, J&K. The requite qualification for IEC Manager requires a

degree of Mass Communication with 10 years' experience. He has produced a fake degree of Mass Comm. Further, he is working for National Conference, J&K for printing IEC material having his shop at Old Zero Bridge Srinagar namely C3 printing.

It is requested to kindly order a high-level inquiry into the conduct of this shameless officer who has abused his high chair with no respect to the rules and regulations set up by the Government. Immediate instructions may be passed to the concerned authorities in the Government to withdraw the said appointments and fill the same through a regular process under rules.
