**Terms of Reference:**

- i) To examine the scope of rehabilitation of the affected families under the Right to Fair Compensation & Transparency LARR Act 2013 or the Municipal Corporation Act, 2000.
- ii) To examine whether there is requirement to restore High Level Committee headed by Divisional Commissioner which was in place to deal with compensation/rehabilitation of dislocated families.
- iii) To ensure strict compliance to all rules, procedure/guidelines issued by the Government from time to time.
- iv) To coordinate with concerned line departments/organizations in the Union territory of Jammu & Kashmir.

The Committee shall submit its report to the Housing & Urban Development Department within a period of 15 days from the date of issuance of the order.
