Subject:- Preliminary notification under Sub Rule (1) of Rule-25 and section-11 (1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, in respect of acquisition of land for construction of road from Machpal to Chamoti, Village Chamoti Tehsil Drabshalla District Kishtwar-Regarding PRELIMINARY NOTIFICATION

Whereas, it appears to the appropriate Government that a total land measuring 102 Kanals 18 Marla of Village Chamoti Tehsil Drabshalla District Kishtwar is required for public purpose namely, acquisition for construction of road from Machipal to Chamoti, Tehsil Drabshalla, District Kishtwar. The Social Impact Assessment study was carried out by the Social Impact assessment (SIA) Unit/team & accordingly has submitted SIA report (SIA report enclosed).

Whereas, perusal of the report reveals that, no family is likely to be displaced due to the said acquisition.



This notification is made under the provisions of section 11 (1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Act no. 30/2013) to all whom it may concern.

A Plan of the land may be inspected in the office of the Collector on any working days during the working hours. The Government authorizes Tehsildar Drabshalla and his staff and officials of indenting department to enter upon and survey the land, take levels of any land, dig or bore into the sub-soil and do all other acts required for the proper execution of their wok as provided and specified in section 12 of the Act.

Further under Sub section (4) of section 11 of this Act, no person shall make any transaction or cause any transaction of land i.e, sale/purchase, etc., or create any encumbrances on such land from the date of publication of this notification without prior approval of the Collector.

Objections to the acquisition, if any, may be filed by the person interested within **60** (**Sixty days**) from the date of publication of this notification as provided under section 15 of the Act before the Collector
