Whereas, the Director, FSL, J&K vide letter dated 21.02.2024 forwarded a proposal for revival of 08 vacant posts of Laboratory Attendants and 01 vacant post of MTS(Orderly), under direct recruitment quota, as these posts had remained vacant for more than two years, and as such had attracted deemed abolition status in terms of circular No. A/97(02)-Sgr-210(S) dated 15.07.2021 read with circular No. FD-Code/67/2022-03-131 dated 03.03.2023, issued by the Finance Department; and
- 2. Whereas, the proposal for revival of 08 vacant posts of Laboratory Attendants and 01 vacant post of MTS (Orderly) was examined and referred to the Finance Department, for concurrence, in terms of circular No. A/97(02)-Sgr-210(S) dated 15.07.2021; and
- 3. Whereas, the Finance Department vide U.O No. FD-Code /445/2021-02-Part(5)315 dated 06.09.2024 conveyed its concurrence as under:

"Returned: The department is advised to issue order for revival of 08 posts of Laboratory Attendant and 01 post of MTS (Orderly) in J&K Forensic Science Laboratory for referral to the designated Recruitment Agency, subject to the following conditions:

- a) The posts proposed for revival shall exist in the applicable Pay Levels as per the relevant Service Recruitment Rules of the department governing the service.
- b) Ensuring that there is indispensable requirement for the same.
- c) The orders shall be issued with the prior approval of Competent Authority in due compliance of the Model Code of Conduct."
