- i. To oversee proper maintenance & cleanliness, usage, treatment of catchment areas of water bodies developed/constructed under Mission Amrit Sarovar Phase-I, with active involvement of local village communities.
- ii. To finalize Amrit Sarovar Sites for Phase-II.
- iii. To implement Mission and ensure its time bound completion.
- iv. To prepare Detailed Project Report (DPR) and earmark sources of funding.
- v. To ensure coordination among participating district-level line departments.
- vi. To nominate Panchayat-Level Officer for each Amrit Sarovar site.

- vii. To conduct monthly review of the progress of the Mission and apprise the Union territory level Committee and State Nodal Officer (SNO).
- viii. To document the achievements and outcomes of the Mission.
- ix. To ensure resolution of grievances and troubleshooting.


