Subject: Age relaxation for the post of Sub-Inspector (SI) in Ladakh Police (Subordinate) Service- reg.

Whereas, the Ladakh Police (Subordinate) Service Recruitment Rules, 2021, notified vide S.O. 37 dated 13.09.2021, specify a minimum age of 18 years and a maximum age of 28 years for direct recruitment to the post of Sub-Inspector in Ladakh Police;

Whereas, representations were received requesting age relaxation and an increase in the maximum age limit for the post of Sub-Inspector, citing that recruitment for these posts has not been conducted since the formation of the Union Territory of Ladakh;

Whereas, in the year 2021, a one-time age relaxation was granted via S.O. 62 of 2021 dated 24.11.2021, which prescribed the upper-age limits for direct recruits as follows: 30 years for Sub-Inspectors, 30 years for Constables, and 37 years for Followers. This order was enforceable for a period of two years, which has now lapsed, rendering the previous age relaxation inapplicable to subsequent recruitments, including for Sub-Inspector posts;

Now, therefore, after due consideration of the representations received, the Lieutenant Governor of the Union Territory of Ladakh is pleased to enhance the prescribed upper-age limit for direct recruitment to the post of Sub-Inspector (Executive Wing, Armed / IRP Wing, HG / CD / UTDRF Wing, and Telecommunication Cadre) in the Ladakh Police (Subordinate) Service by two (02) years.

This two-year age relaxation in the upper-age limit shall be a one-time exception and will remain in force for a period of two years from the date of issuance of this Order.



Note: Recruitment for posts already advertised before the issuance of this Order shall continue to be governed by the provisions specified in the respective advertisements.
