Terms of Reference:

- i. To undertake comprehensive review of all existing and proposed/ upcoming/ under-development wayside amenities, especially toilets, along major roads/ highways/ road connecting tourism sites across J&K for assessing their physical as well as functional status and suggest steps for improvement. The review shall cover all wayside amenities with free public access, being maintained or developed by Tourism Department, NHAI, NHIDCL, BRO, PW(R&B) etc.
- ii. To suggest uniform distance and size norms vis-à-vis toilet complexes linked to the tentative numbers of daily commuters.
- iii. To suggest a self-sustaining model for the functional maintenance of toilet complexes and have an inbuilt mechanism

- for regular physical and functional quality assessment.
Mechanism of public feedback may also be suggested.
- iv. To undertake regular monitoring of the wayside amenities, especially toilet facilities, for improvements made and required.
