Subject: Addendum to Notification No.: LA (Trm)/Homestay/2023/(53)/3748-55 [SG-LD-E-22102023-1267], dated 22 October 2023& Subsequent Addendum to Ladakh Gazette Notification No.: SG-LD-E-24072024-1336, dated 24July,2024 & Ladakh Gazette Notification No.: SG-LD-E-19092024-1374, dated: 17.09.2024.

- 1. Section 9, titled 'Selection of the Homestay Beneficiaries' now outlines a process for determining eligible homestay beneficiaries, based on the following structured framework:
  - (1) First preference shall be given to households with no employed individuals/ individuals having no other business, Ex-Agniveers, Ex-Servicemen, who have completed their full-colour service in the Armed Forces, Women Self-Help Groups candidates and new entrepreneurs (individuals or households with no prior ownership of guesthouses, hotels or campsites) in that order.
  - (2) Individuals or households, currently running a business in the tourism or hospitality sector, such as hotels, guesthouses, travel agencies, or related ventures, will not qualify for incentives under the policy.
  - (3) All other terms and conditions of the Ladakh Homestay Policy 2023 would remain unchanged and continue to be in effect.
