Terms of Reference:

- i. To prepare and suggest a roadmap along with holistic framework for strengthening the governance structures of selected Tourism Development Authorities.
- ii. While preparing the empowered framework, the committee shall keep in consideration the following (not limited to):
 - a. Challenges/issues from past learnings.
 - b. Financially viable governance structures.

- c. Balancing the developmental needs with ecological sustainability and carrying capacity of ecosystem.
- d. Understanding the best practices/ success from across India/World and localizing those practices.
- e. Limiting the role of government to basic/essential infrastructural requirements for supporting development while facilitating private developers subject to strict, fair and transparent enforcement/ regulation.
- f. An empowered organization with in-built check and balance mechanism.
