Sanction is hereby accorded to the release of additional funds amounting to Rs. 304.00 lakh (Rupees three crore four lakhs only) under Capex Budget 2024-25 Demand No. 08-Finance Department 08-5475-00-800-0011-1304-2-V-Moderanization and Infrastructure Development-115-works and its placement thereof at the disposal of Director State Motor Garages , J&K for Purchase of 08 new vehicles (Toyota Fortuner) as mentioned in the matrix below alongwith Advance Drawal to the extent of Rupees to be emerged out as L1 or Rs. 304.00 lakh , whichever is less, subject to fulfillment of GFR -2017:-

- 1. There shall be no Idle parking of the amount at all.*
- 2. No Post of Driver shall be created.*
- 4. FA/CAO of the State Motor Garages (SMG) shall vouchsafe the availability of funds for the purpose they are meant for.*
- 5. The Director ,SMG shall utilize the funds after fulfillment of all the codal formalities and after following due e-tendering process as per Manual of Procurement of Goods and GFR stipulations.*
- 6. The funds shall not be available for re- appropriation or*

diversion/deviation at any level.

7. *The UC's of the advance drawal shall be furnished to all the concerned quarters within stipulated time but before 31-03-2025.*
8. *The Director, SMG shall reflect the additionality in the RE 2024-25.*


