



"As per the decision taken in the meeting/discussion held on 11.10.2024, the department is conveyed as under:

1. Finance Department conveys concurrence to the departmental proposal for hiring of consultancy for implementation of Business Reforms Action Plan (BRAP) 2024 for the period upto 31.03.2025 in terms of GFR.
2. The PMU of Finance Department shall look into the implementation of GIS for all IE's along with integration with IILB portal.
3. The Department shall invite tenders for Single Window Portal- Development of new features, services as per BRAP 2024 and operation and maintenance of existing services on SW portal.
