Subject: Promotion of Trained Graduate/Post-Graduate Teachers as Masters- Adjustment thereof.

Whereas, pursuant to the decision of the Divisional Departmental promotion Committee in its meeting held on 23/11/2024, **Three hundred Seventy Two (372)** trained graduate/Post-graduate teachers were promoted/Confirmed as Masters in the Pay Level **6E (35900-113500)** w.e.f **06/07/2024** on notional basis and monetarily from the date they assume the post physically vide this office Order under referenceread with Order No. 271-DSEK of 2024 dated:- 11/11/2024, issued under endorsement No. DSEK/Estt-III/A/1588-1606 Dated:- 11/11/2024; and

Whereas, **Four (04)** trained graduate/Post-graduate teachers who among others were promoted as Masters vide Order under reference, have either attained the age of superannuation or expired as on date, leaving behind only **Three hundred and Sixty Eight (368)** promotes whose adjustment against available vacant posts of Masters is to be considered.

Now, therefore, sanction is hereby accorded to the adjustment of **Three hundred and Sixty Eight (368)** Promotees as Masters against the postsas shown against each in the **Annexure A to J** to this Order, on the same terms and conditions as laid down in this office Order under reference, reproduced as under:-

- The Chief Education Officer concerned shall verify the particulars of each of the official(s) with reference to his/ her Original service records/ appointment Order/ regularization Order/ promotion order and ensure that the details recorded against each official (herewith in the Annexures of this Order) are correct. Variations, if any found, should be immediately brought into the notice of this Directorate for further orders and in that case, no such official shall avail the benefit of promotion until further clarification/ instructions in the case is sought from this Directorate.
- The Chief Education Officers before implementing the Order, shall satisfy themselves about the genuineness of qualification/degree certificates and ensure that the official(s)has/have qualifiedif any course/degree during in-service.has/have obtained prior permission from the competent authority as per Circulars/ instructions/ Orders/ Notifications issued by the Competent Authority at the relevant point of time.
- The promotion so accorded is without pre-judice to the outcome of Writ Petition(s), if any, pending before Competent Court of Law, which is not immediately within the knowledge of this Directorate.

- d. Latest Vigilance Clearance Certificate in respect of each such official.
- e. Last 03 years satisfactory APRs.
- f. That the official must necessarily be holding genuine appointment on substantive basis, in the department and has been appointed/ selected by the Competent Authority and has uninterrupted service, and shall not fall in the category of Fake, Fraud, Adhoc/ Contractual appointment/Migrant substitute and there is nothing adverse against the official(s) from VOK/Crime/ Police or any other agency.
- g. The benefit of promotion shall not be allowed in case of such official(s) who is/are either under suspension or whose suspension period is still undecided or against whom the departmental/VOK proceeding is presently pending or in case where the seniority of a teacher by the period of non-qualifying services/dies-non has not been altered/deferred by the said period.
- h. Satisfactory Integrity/ Work & Conduct Certificate from the concerned Drawing and Disbursing Officer.
- i. Good Result percentage of the subjects taught by the official(s).
- j. An affidavit duly executed before 1st Class Magistrate, to the effect that there is no Court case, investigation whatsoever nature pending before the Department or any investigating agency against the official(s).
- k. The in-situ promotion availed by the promotee during his/her tenure in the Department shall also be withdrawn from such promotees, who fails to avail the promotion as laid down under Rule 10 of SRO-14 dated 15-01-1996.
- l. Up-dated service verification certificate of each official.
- m. That superior claim (for inclusion in the promotion), if any, shall reach this Directorate through proper channel within a period of 15 days from the date of issuance of this order and no claim whatsoever shall not be entertained after the stipulated time frame.

The promotees must necessarily join at their new place of postings within 07 days from the date of issue of this order, failing which it shall be presumed that they have foregone the promotion.
