WHEREAS, vide Government Order No. 296-JK(Edu) of 2024 Dated 30.07.2024 Sh. Nazir-ul-Hussain Shah, Lecturer Environmental Science BHSS, Sogam Kupwara was placed under suspension and attached in the office of Chief Education officer, Kupwara. Further, vide ibid order, the Director, School Education, Kashmir was directed to conduct an inquiry in the matter;

WHEREAS, Director School Education, Kashmir vide letter No. DSEK/Estt-I/925 dated 11.09.2024 has submitted a detailed inquiry report in the matter.

WHEREAS, after examining the inquiry report, the case was placed before the Suspension Review Committee, which met on 02.01.2025 under the chairmanship of the then Principal Secretary, to the Government, School Education Department, and in the instant case the Committee decided as under:-

- 1. The Committee on the basis of the Inquiry report submitted by Director School Education, Kashmir recommended for reinstatement of the officer with immediate effect. Furthermore the officer shall be censured.
- 2. The period of suspension to be treated as on duty under rules.

WHEREAS, the case has been examined in light of the decisions of the Suspension Review Committee and submitted to the Competent Authority for consideration and approval to the recommendations of the Committee.

NOW, THEREFORE, sanction is hereby accorded to the reinstatement of Mr. Nazir-ul-Hussain Shah, Lecturer Environmental Science BHSS, Sogam Kupwara presently attached in the office of Chief Education Officer, Kupwara with immediate effect Further, in terms of Rule-30 of J&K Civil Services, (Classification, Control) and Appeal Rules, the officer is censured and the period of suspension is treated as on duty, under rules.

Besides, it is ordered that he shall work in Boys Higher Secondary School, Sogam Kupwara as per G.O No. 263JK(Edu) dated 15.07.2024. till further orders.
